LAINGSBURG DEMAND MANAGEMENT AND METERING

The **LAINGSBURG MUNICIPALITY** invites tenders for Tender No. T01 - 2021 / 2022: Laingsburg Demand Management and Metering: Laingsburg and Matjiesfontein Water Network Improvements.

It is estimated that tenderers should have a CIDB contractor grading designation **4CE/PE** or higher.

Only tenders scoring a minimum of 60 out of 100 will be considered further for evaluation.

This invitation adheres to the principles of local content. **ONLY** locally produced or manufactured goods with a stipulated minimum threshold for local production and content will be considered. The bid documentation that will be submitted **MUST** be subject to local content as set out in the specifications.

Tenderer must be registered and tax-compliant on the Centralised Supplier Database (CSD). Tenderers can register on www.csd.gov.za.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **Monday, 19 July 2021, 09h00** at the **Supply Chain Management Unit, 02 Van Riebeeck Street, Laingsburg, 6900** or at **iX Engineers (Pty) Ltd, 31 Allen Drive, Loevenstein, Bellville, 7535** during office hours (08h00 – 15h00).

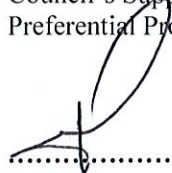
