EXPRESSION OF INTEREST FOR CAPITAL PROJECTS FINANCING

Laingsburg Local Municipality (LLM) invites all interested Service Providers to submit an expression of interest for the provision of finance options on capital projects.

Submissions must include a list of contactable references where similar services were provided in the past 36 months. All service providers who submitted valid expression of interest will shortly be invited for a detailed presentation in line with their submission. LLM has no obligation to appoint whole or partly any potential service provider of expression of interest for the provision of finance on capital projects within LLM.

Notes to Prospective Bidders / Compulsory Submissions

- 1. All prospective bidders must be registered on the Central Supplier Database (CSD).
- 2. All bids submitted should remain valid for a period of 90 days after the expression of interest closing date.
- 3. Original Valid Tax Clearance Certificate.
- 4. Certified Copies of Broad-Based Black Economic Empowerment (B-BBEE) Level Certificate.
- 5. Company Profile
- 6. Joint Venture Agreement (where applicable)
- 7. Bidders are required to submit Proposed Project Team, their CV's.
- 8. All prospective bidders are required to submit MBD 4 forms, Declaration of Interest forms (completely filled by all members of the company or a Certificate for Authority of Signatory authorizing one member to sign on behalf of all members of the company). Declaration of Interest forms are available on request from the Supply Chain Management Unit of Laingsburg Local Municipality. Failure to complete MBD 4 forms will result in disqualification.

Completed expression of interest for the provisioning of finance of capital projects with LLM in sealed envelopes endorsed: "Notice No. 32/2017 – Expression of Interest for Capital Projects Financing" must be sealed and signed off the register for submission and placed in the tender box at the Municipal Buildings, Van Riebeeck Street, Laingsburg or posted to reach the Acting Municipal Manager not later than 12:00 pm on 12 April 2017. Late, incomplete, electronic, telegraphic, telefaxed, expression of interest will not be considered.
