The Laingsburg Municipality invites tenders for the Construction of a Bulk Raw Water Pipeline from the Soutkloof Reservoir to the Town Reservoir in Laingsburg.

**It is estimated that tenderers should have a CIDB contractor grading of 6CE/PE or higher.**

Only tenderers who satisfy the criteria stated in the Tender Data are eligible to submit tenders. Tenders may only be submitted on the prescribed tender documents that are obtainable from **Wednesday, 01 November 2017** at **Aurecon, Aurecon Centre, 1 Century City Drive, Waterford Precinct, Century City, Cape Town**, or at the compulsory site inspection meeting.
