Only tenderers who have in their full time employ a person/s registered with the South African Council for the Project and Construction Management Professionals (SACPCMP), or capable of registering as per the Registration Criteria of SACPCMP, in the following category: a. Construction Health and Safety Agent (PrCHSA).

Where Tenderers are not registered yet, they must submit proof of application for registration to SACPCMP in the above category with their tender and proof of compliance with the Registration Criteria of SACPCMP, for evaluation purposes.
