## MAINTENANCE, SERVICING AND REPAIR OF FLEET VEHICLES

Laingsburg Municipality hereby invites tenders from suitably qualified service providers to be appointed to a Panel of Service Providers for the maintenance, servicing, and repair of municipal fleet vehicles for a period of three (3) years.

The Municipality intends to appoint all qualifying local workshops to a panel. This tender is subject to eligibility criteria and bidders must provide proof where required, as specified in the tender document.

**Non-compliance with the eligibility criteria will render the bidder non-responsive.**

Completed tenders in a sealed envelope, endorsed with "**SCM-T-2025-26-010 - Maintenance, servicing and repair of municipal fleet vehicles**," must be placed in the tender box in the foyer between 08:00 – 15:00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager no later than **12:00 p.m. on 16 March 2026**, after which tenders will be opened in public.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **Monday, 16 February 2026** at the **Supply Chain Management Unit, 02 Van Riebeeck Street, Laingsburg, 6900** during office hours **(08h00 - 16h00)**.

A non-refundable participation fee of **R 700.00 (Seven Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **SCM-T-2025-26-010 - Company Name**.
