Requirements: • Driver's license • Public Driver's Permit will be an advantage • 3 years' experience operational and maintenance experience on medium voltage electrical distribution and reticulation equipment, Pass a recognised trade test as an electrician, in possession of a trade test certificate (Red Seal), physically fit and healthy, work overtime in accordance to the overtime policy of the municipality, effective communication skills in at least two of the three Western Cape official languages, Must be reliable, responsible and pay attention to detail, Wireman's License, qualification in ORHVS will be an advantage, certificate undertaking MV joining will be an advantage, Valid Authorisation from GMR 2.1 will be an advantage. Will serve as a recommendation.

Key Duties: Plan and set out task for the different sections of the sub directorates of the department. Manage the financial, human and material resources of the directorate. Responsible of disciplinary of the sub directorate. Maintaining, Constructing, installing and commissioning of electrical networks of the municipality. The following electrical equipment but not limited to:

- Up to 22kV overhead lines and underground cables, switchgear, mini-substations, ring main units, transformers, 400v/230v distribution kiosk, and allied work.
- Up to 22kV cable joining using both compound and heat shrink joints.
- Maintaining street lightings and high mask light.
- Installation of new domestic connections and prepaid meter installations and conversions.
- Undertake the increase/decrease of tariff circuit breakers.
- Undertaking inspections of electrical installation and report on findings in respect of guidelines provided.
- Responsible for on-site OHS and supervision of labour.
- Perform overtime and standby duty.
