Only tenders scoring a minimum of **70** out of **100** for functionality will be considered further for evaluation.

Completed tenders in a sealed envelope, endorsed with **“SCM-T-2025-26-001 - Provision of internet and telephone services for Laingsburg Municipality,”** must be placed in the tender box in the foyer between 08:00 – 15:00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager no later than **10:00 a.m. on 01 September 2025**, after which tenders will be opened in public.

Tenders may only be submitted on the prescribed tender documents, obtainable from **01 August 2025**, starting at 08:00 at Laingsburg Municipality, 02 Van Riebeeck Street, Laingsburg, 6900 during office hours (08:00 – 15:00).

A non-refundable participation fee of **R 700.00 (Seven Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **SCM-T-2025-26-001 - Company Name**.
