It is estimated that tenderers should have a CIDB contractor grading designation of **2GB** or higher.

This tender is subject to eligibility criteria and bidders must provide proof where required, as specified in the tender document.

Non-compliance with the eligibility criteria will render the bidder non-responsive.

Bidders uncertain of the location of the compulsory briefing session may enquire at the Municipal Office before **10:00 am** on the day of the meeting.

Tenderers must be represented at the site visit/clarification meeting by a suitably qualified and experienced person who would be able to comprehend the implications of the work involved. The representative must be an employee of the Tenderer.

No representative at the meeting may represent more than one Tenderer. The Municipality reserves the right to verify the representative's employment status.

A non-refundable participation fee of **R 700.00** (Seven Hundred Rand) will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**.
