RENO MATTRESS FOR GÖLDNERVILLE STORMWATER

The LAINGSBURG MUNICIPALITY invites tenders for Tender No: T09 – 2021/2022 - Reno Mattress for Goldnerville Stormwater.

It is estimated that tenderers should have a CIDB contractor grading designation of **3CE, 2CE-PE** or higher.

This invitation adheres to the principles of local content. **ONLY** locally produced or manufactured goods with a stipulated minimum threshold for local production and content will be considered. The bid documentation that will be submitted **MUST** be subject to local content as set out in the specifications.

Tenderer must be registered and tax-compliant on the Centralised Supplier Database (CSD). Tenderers can register on www.csd.gov.za.

Only tenderers who satisfy the criteria stated in the Tender Data are eligible to submit tenders. Tenders may only be submitted on the prescribed tender documents that are obtainable from **Tuesday, 15 February 2022**, during office hours (**08H00 – 16H00**).

A non-refundable participation fee of **R 250-00 (Two Hundred and Fifty Rand)**, is applicable. The fee must be deposited into the account of the Laingsburg Municipality at **Absa Bank**, Branch Code: **334508**, Account Number **2540140874**. The reference number for confirmation of payment is **T09 - 2021/2022 - Company Name**. Proof of payment of the participation fee should accompany your tender document when submitting it. Completed tenders in a sealed envelope endorsed with: **“Tender T09 - 2021/2022 – Reno Mattress for Göldnerville Stormwater”** must be placed in the tender box in the foyer between (08H00 – 16H00) at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager not later than **12:00 pm on 14 March 2022**, after which tenders will be opened in public.

A compulsory briefing session will be held at **11h30 on Friday, 25 February 2022** at the **Tourism Centre, Auditorium, Meiring Street Laingsburg**. No grace period will be allowed. COVID-19 protocol will be applicable.
