REFURBISHMENT OF SEWER PUMP STATIONS

Laingsburg Municipality hereby invites tenders for Tender No. T02 - 2023 / 2024 – Refurbishment of sewer pump stations.

It is estimated that tenderers should have a CIDB contractor grading designation of **5CE / ME** or higher.

Only tenderers who can demonstrate that they will have in their employ staff who satisfy EPWP requirements during the contract validity are eligible to submit tenders.

Only tenders scoring a minimum of **75** out of **100** for functionality will be considered further for evaluation.

Completed tenders in a sealed envelope endorsed with “**Tender T02 - 2023 / 2024 – Refurbishment of sewer pump stations.**” must be placed in the tender box in the foyer between (08H00 – 15H00) at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager not later than **12:00 pm** on **28 July 2023**, after which tenders will be opened in public.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **11 July 2023**, 08h00 at Laingsburg Municipality, 02 Van Riebeeck Street, Laingsburg, 6900 during office hours (08h00 – 15h00) or at WEC Consult, Unit 24, Oewerpark, Rokewood Road, Die Boord, Stellenbosch, 7613.

A compulsory briefing session will be held at **14:00 pm** on **Wednesday, 19 July 2023** at the Laingsburg Flood Museum, Tourism Auditorium, Meiring Street, Laingsburg. No grace period will be allowed.

Tenderers must be represented at the site visit/clarification meeting by a person who is suitably qualified and experienced to comprehend the implications of the work involved. The representative must be an employee of the Tenderer. No representative at the meeting may represent more than one Tenderer.

A non-refundable participation fee of **R 500-00 (Five Hundred Rand)**, is applicable. The fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code: **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **T02-2023/2024 - Company Name**. Proof of payment of the participation fee should accompany your tender document when submitting it. The **bid must be valid for a period of 120 days** after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Municipal Preferential Procurement Policy, and the Preferential Procurement Regulations, 2022.
